BRIEF DESCRIPTION OF DUTIES: The incumbent works closely with the Office of the Chief Financial Officer and other District government stakeholders in the analysis, planning, design, implementation, documentation, assessment, and management of the enterprise structural framework. Performs work to align IT strategy, plans, and systems with the mission, goals, structure, and processes of the organization. Develops reference models of the enterprise and maintaining the information in the IT repository; determines the gaps between the current and the target architecture and developing plans for transitioning to target architecture. Provides enterprise architecture guidance, support, and coordination to customers and IT project team; coordinates and conduction governance and portfolio management activities associated with ensuring compliance with the enterprise architecture; ensures the rigorous application of information security/information assurance policies, principles, and practices to all components of the enterprise architecture. Incumbent must have a sound understanding of Information Technology systems, architecture, technologies and infrastructure, in order to review and design information technology systems architecture, provides leadership and guidance to lower level staff, and ensure that OCFO systems utilize latest technologies and IT best practices.

MINIMUM QUALIFICATIONS: One (1) year of Specialized Experience performing the related duties and responsibilities at the next lower level. **Bachelor's and Master's degree in engineering, business administration, computer science or IT discipline is highly desired.**

SPECIALIZED EXPERIENCE: Experience that provides the applicant with the particular knowledge, skills, and abilities to perform successfully the duties of the position, and that is typically in or related to the work of the position to be filled. To be creditable, specialized experience must have been equivalent to at least the next lower grade level in the normal line of progression for the occupation in the organization.

- 3) Application Software (APPSW)
- 4) Operating Systems (OS)
- 5) Network Services (NETWORK)
- 6) Data Management (DATAMGT)
- 7) Internet (INET)
- 8) Systems Administration (SYSADMIN)
- 9) Customer Support (CUSTSPT)
- 10) Project Management (PMP certification required for the project management specialization)

2. Advanced professional certifications in specialized areas of Information Technology are highly desired. Examples of highly desired certifications include PMP, Six Sigma, ITIL foundation, CMM, MCSE, MCSA, Oracle, Cognos, CCNP, CCIE, etc.

3. Demonstrated experience and knowledge of enterprise architecture and IT management concepts including Systems Development Life Cycle (SDLC) models, Production support processes, Hardware and software architecture and technologies, Infrastructure management and design concepts, Project Management principles (PMI), Web systems, IT security management and compliance.

SUBSTITUTION OF EDUCATION FOR EXPERIENCE WILL BE ALLOWED AS DEFINED BY OPM'S, QUALIFICATIONS STANDARDS. RESIDENCY PREFERENCE AMENDMENT ACT OF 1998: An external applicant for a position in the OCFO who is a bona fide resident of the District of Columbia AT THE TIME OF APPLICATION, may claim a hiring preference over a non-resident applicant by completing the 'Residency Preference for Employment' form, [DC 2000RP](#), and submitting it with the employment application, [DC 2000](#). Except for employees entitled by law to preference, preference will not be granted unless the claim is made at the time of application. This preference is only granted upon initial appointment.
