FY 2015 June Financial Status Report

I am pleased to provide the FY 2015 June Financial Status Report for your review. The report is based on the results of operations (expenditures and commitments versus budget) through June 30, 2015.

Current and historical results of operations are also available via the District's online systems including CFO\$olve and the Executive Dashboard.

The Financial Status Report is a comprehensive review of the District's operating accounts, with particular focus on Local funds. The report is prepared on a "fiscal year" basis, similar to the District's CAFR, and includes all financial transactions posted in FY 2015 as well as all active encumbrances regardless of appropriation year of origin.

The financial status report contains:

- District-wide reports;
- Fund-level reports; and
- Agency-specific reports

The attached reports were generated on July 21, 2015. Any differences between these reports and SOAR, the District's financial system, are due to June 2015 accounting events (or earlier) that may have been recorded in the system subsequent to the report run date of July 21, 2015.

Status of District-Wide Spending and Commitments

Local Funds

As of June 30, 2015, SOAR indicates that District agencies spent and committed (expenditures, encumbrances, intra-District advances, and pre-encumbrances) \$5.237 billion of their \$6.677 billion Local funds budget. This leaves a total available balance for the District of \$1.439 billion, or 21.6 percent of their Local funds budget, for the remaining 3 months or 25.0 percent of the year.

The rate of expenditures alone through June 30, 2015 is 71.2 percent of the budget, which is slightly more than historical rates. On average, during the past three fiscal years (FYs 2012, 2013, and 2014), agencies had spent 70.8 percent of their annual Local funds budget through the first nine months of the fiscal year.

See Attachment A for a table summarizing key Local funds budget increases and decreases in FY 2015 through June 30, 2015.

Gross Funds

Agencies spent or committed \$7.995 billion of their \$10.974 billion budget from all funding sources through the first nine months of FY 2015, leaving \$2.979 billion, or 27.1 percent, for the remainder of the year. The rate of expenditures alone was 66.1 percent of budget, which is less than the three-year historical average of 68.7 percent for gross funds.

To date, District agencies have spent or committed 62.2 percent of their Dedicated Tax funds, 65.0 percent of their Special Purpose Revenue funds ("O"-type funds), 51.6 percent of their Federal Grants, 49.5 percent of their Federal Payments, 71.9 percent of their Federal Medicaid budgets, 40.1 percent of their Private Grant budgets, and 38.4 percent of their Private Donations budgets.

Top Ten Agencies

The top ten agencies, ranked by their Local funds budgets, spent or committed \$3.419 billion in the first nine months, or 82.8 percent of their \$4.127 billion Local funds budgets. This leaves \$0.708 billion, or 17.2 percent, for the remaining three months of the year. All District agencies as a whole spent or committed \$5.237 billion, or 78.4 percent of the \$6.677 billion Local budget. Thus, the top ten agencies spent or committed at a rate higher than all District agencies as a whole. The top ten agencies account for about 61.8 percent of the District's Local funds budget.

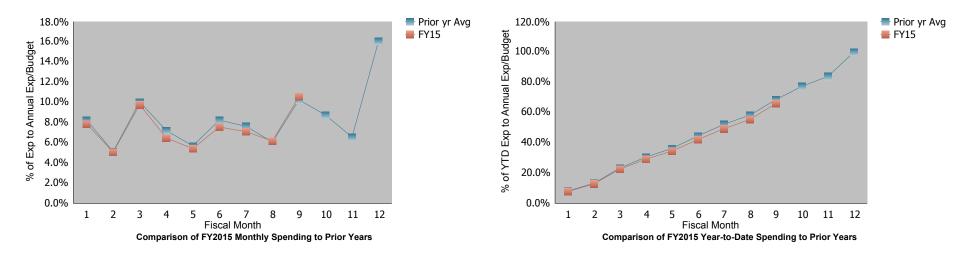
