Pursuant to the Capital Project Support Fund Establishment Act of 2009, I am transmitting this report on the status of the Capital Project Support Fund for the second quarter of FY 2022, the period from January 1, 2022, through March 31, 2022.

During the second quarter, the Office of Budget and Planning worked with agencies to close out old, inactive project balances and old, inactive capital intra-District advances per the legislative authority. A total of \$114,806.31 was transferred from six capital projects to the Washington Metropolitan Area Transit Authority Support Fund project, SA311C.
