Pursuant to the District Department of Transportation Capital Project Review and Reconciliation Amendment Act of 2012, effective September 20, 2012, I am transmitting this report on the quarterly status of District Department of Transportation (DDOT) capital project review and reconciliations.

During the first quarter of FY 2022, my office and agency capital budget staff closed 12 Highway Trust Fund (HTF) projects totaling \$1,143,823.07. These budgets were moved back to their respective Master Projects. No Local Transportation funded projects were closed.

There were no HTF projects or Local Transportation funded project reconciled during this quarter.
