Pursuant to the District Department of Transportation Capital Project Review and Reconciliation Amendment Act of 2012, effective September 20, 2012, I am transmitting this report on the quarterly status of District Department of Transportation (DDOT) capital project review and reconciliations.

During the third quarter of FY 2023, my office and agency capital budget staff closed one Highway Trust Fund (HTF) project totaling \$124,626.79. One Local Transportation funded project was closed totaling \$79,979.93. These budgets were moved back to their respective Master Projects.

There were no HTF projects or Local Transportation funded projects reconciled during this quarter.
