Dear Mayor Bowser and Chairman Mendelson:

Pursuant to the Capital Project Support Fund Establishment Act of 2009, I am transmitting this report on the status of the Capital Project Support Fund for the fourth quarter of FY 2023, the period from July 1, 2023, through September 30, 2023.

During the fourth quarter, the Office of Budget and Planning worked with agencies to close out old, inactive project balances and old, inactive capital interagency advances per the legislative authority. A total of \$41,059.03 was transferred from six capital projects to the Washington Metropolitan Area Transit Authority Support Fund project, SA311C.
